POOL UPDATE

On behalf of all members of the HOA, the board has been working on evaluating the pool reopening requirements as set forth by the state and local authorities for the past several weeks. The following steps have been taken to date:

- The pool has been professionally cleaned, opened and is being regulated each day by LSV staff to ensure readiness if/when re-opening occurs
- We have communicated with the local health department to clearly understand what the opening inspection will require and timing for inspection
- Additional ZOOM meetings have been held with board members to discuss pool issues in detail
- A volunteer committee of homeowners has met and submitted a set of recommendations to the board. The board appreciates this additional help and is reviewing all recommendations as they relate to the state guidelines.
- The board has contacted several HOAs in Lexington with similar size communities to gather information on and discuss what these communities are doing and what decisions are being or have been made.
- A board member is attending national association teleconferences covering HOA legal and liability issues regarding pools during a pandemic
- LSV insurance coverage is being evaluated

The following is an update on what is happening at the lake:

- A sizable load of river pebbles was anonymously donated and delivered for the boat launch area. All reports so far indicate this has been a significant improvement in that area. Thank you to the donor and to those homeowners who helped spread the rock.
- A new custom kayak dock for the same area has been ordered. It will also provide easier access to the water. We hope to have it installed later this month.
- LELA conducts water testing on a regular basis and to date, no use restrictions are in place. The LSV HOA will also conduct additional testing this summer.
- New signage has been installed to deter trespassing on the lakefront and dock.
